Dear Vice Chair Anderson

**Re: OLRB File # 1115-04-U**

The **Horochowksi tape** on the CD enclosed, was sent to me by Ed Chudak on Feb. 16, 2005 by email. It is the recording of the interview in Sault Ste Marie with OECTA that was ordered by the Labour Relations Tribunal. This recording was not included in any of Chudak's correspondence with Labour Relations in the letter dated May 11, 2005, which questioned my competence. Chudak did however, include an email on Feb 16, 2005, stating that he sent the audio file to me. (A copy of this letter is enclosed.)

The conversation reflects Ed Chudak's neglect of my concerns with Holy Cross principal Cosmo Modafferi (the reason why I was disabled in 1993 and 1995), the disinformation and dangers of the New Curriculum, why I was forced to resign from fulltime teaching in Feb. 2003 and why I had to build [www.JrGenius.com](http://www.JrGenius.com) in 1996 as a result of not being able to improve the system from within. Chudak would interrupt me while I spoke and would change the topic. He spoke over my voice when I mentioned the Illuminati as a reason for my resignation in 2003. To the end of the conversation, he concluded that Long Term Disability seemed like the only viable option (which would bankrupt Jrgenius.com). Questioning my mental health in a degrading fashion, he finally tried to coerce me into seeing a psychiatrist in the Sault. I did not agree to going to Toronto at any point in this conversation.

This was never presented to the Labour Board for the records. It strongly supports my defense in this case, which further **proves that I am fit to teach and very willing to work as a teacher**. I have enclosed a recent resume/portfolio package that I send out to all jobs that I apply for. Needless to say, I am not teaching in the public system due to the negative roadblocks by the York Catholic District School Board and OECTA. Potential employers ask me why I am applying for low level jobs and not teaching in the school system or why am I not running Jrgenius.com full time. I then must mention this situation and that sends them running in fear.

Psychiatrists will avoid this issue, since it does challenge the integrity of the practice of psychiatry and medicine. I saw Dr. Macmichael on Feb 8, 2006 and had an excellent appointment with him. He was going to write me a mental fitness letter after that appointment. I also saw him and had a clean bill of health in August 2005.

Dr. Macmichael hesitated to respond when Bernard Hanson (letter dated Feb 13, 2006) sent in those additional questions with the 53 page letter that I sent to Ed Chudak on March 14, 2005 questioning my mental health and competence. There is a delay in getting another psychiatrist to take my case because of the subject matter, not because of my competence. I have proven my competence as being an outstanding educator. My resume reflects my many accomplishments, teaching records and talents. My recent past employer (Adults in Motion Private School) has given me an incredible reference letter. **So I question where the incompetence lies- with me or OECTA and YCDSB?**

I would like you to view the files on the CD. **I have sent this CD to the 5 other parties.**

I have attached the web page and other materials to the file that are on the [www.holyhealthy.com](http://www.holyhealthy.com) in the **Unfit to Teach? Who is? Not me!** Link. This proves that I am fit to teach and that OECTA and the York Catholic District School Board are not willing to cooperate in this matter.

I await your decision in this Labour Relations dispute. I do not want to dismiss this case and hope that a settlement can be reached finally.
